REGISTRATION FORM AND CONTRACT AGREEMENT

I understand and agree to the following:

- 1. Tuition will be paid by the trimester. Tuition will be due in August, November, and February. Any tuition not paid by the 15th of that month will be charged a \$10 late fee.** Tuition must be kept current in order for the student to participate in class.
2. Tuition must be mailed to P.O. Box 1258 or brought to the studio. Tuition is based on the dance season from August to May and not on individual classes or months. There are no refunds for missed classes.
3. There will be a \$30 fee for any returned checks.
4. All new students must pay a non-refundable \$25 registration fee. Any returning students registering after April 30, 2015 must also pay a \$25 non-refundable registration fee.
5. Students must abide by the studio rules set forth in the studio brochure. Failure to do so may result in dismissal from the class.
6. Students must be dressed properly for class. Girls may wear a solid colored black or pink leotard with tights. No pants for ballet. No bare legs, t-shirts, costumes, or baggy clothing allowed for class. Boys may wear shorts or dance pants and a solid colored shirt. Any student not dressed properly for class may be asked to sit out and observe for that day. Students in Ballet Company must wear the required black leotard and pink tights. Competition dancers must wear the required uniform to every class. Proper shoes must be worn to every class. Each class will be told what shoes to wear in the studio brochure. All shoes should be labeled with the dancers name or initials.
7. Any dancer that decides not to continue with dance classes must give the teacher a 30 day written notice. Any dancer who quits is responsible for paying for that month. Dancers who drop after recital dances have started will be required to pay a \$50 choreographer's fee for the changes that have to be made.
8. Our annual recital will be held in the Reidsville Senior High Auditorium. Technical and Dress Rehearsals will also be held in the auditorium. Rehearsals are mandatory in order to participate in the recital. Any dances missed in the rehearsal will not be performed in the recital. Dates will be announced ASAP.
9. Any child wanting to participate in the annual recital will be required to pay a \$50 recital fee. The recital fee helps to cover the cost of auditorium rental, scenery, props, sound and production crew, lighting, programs, etc.
10. Costumes- Dancers participating in the recital will be required to purchase a costume for each class they participate in. Costumes average around \$65 for child sizes and \$75 for adult sizes. Half of the costume bill will be due in October, and the remainder will be due in December. Costumes will not be ordered unless they are paid for in full. You may add extra to your monthly tuition to go towards costumes before December if you like. Once costumes are ordered, they are non-refundable.
11. **RELEASE:** As additional consideration for the student's instruction, the undersigned hereby releases Academy of Dance for injuries to the person or property of the student which may occur while participating in the activities of the studio. The undersigned further agrees to indemnify Academy of Dance in the event any claims are asserted against it arising from the student's participation in the activities of the school.
12. Academy of Dance shall have the right to use the name, photograph, video tape, or other likeness of the dancer; and to exhibit the same through any medium whatsoever during the term of this agreement or at any time in the future for advertising, promotional or commercial purposes. All such reproductions shall be exclusive property of Academy of Dance.
